## Loyalist Group Limited Expands South Korean Government Sponsorship to PGIC Vancouver

Toronto, Canada – February 2<sup>nd</sup> 2012 – Loyalist Group Limited (TSX Venture Exchange: LOY) (“Loyalist” or the “Corporation”), is pleased to announce that the Company has received approval from Human Resources Development South Korea (HRDSK), a ministry of the South Korean government, to accept 50 fully sponsored students for the first time at PGIC Vancouver.
